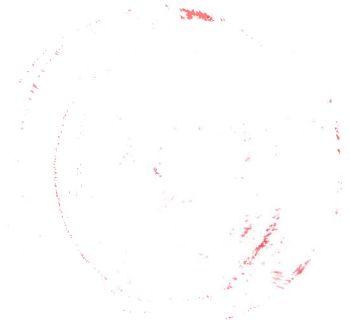

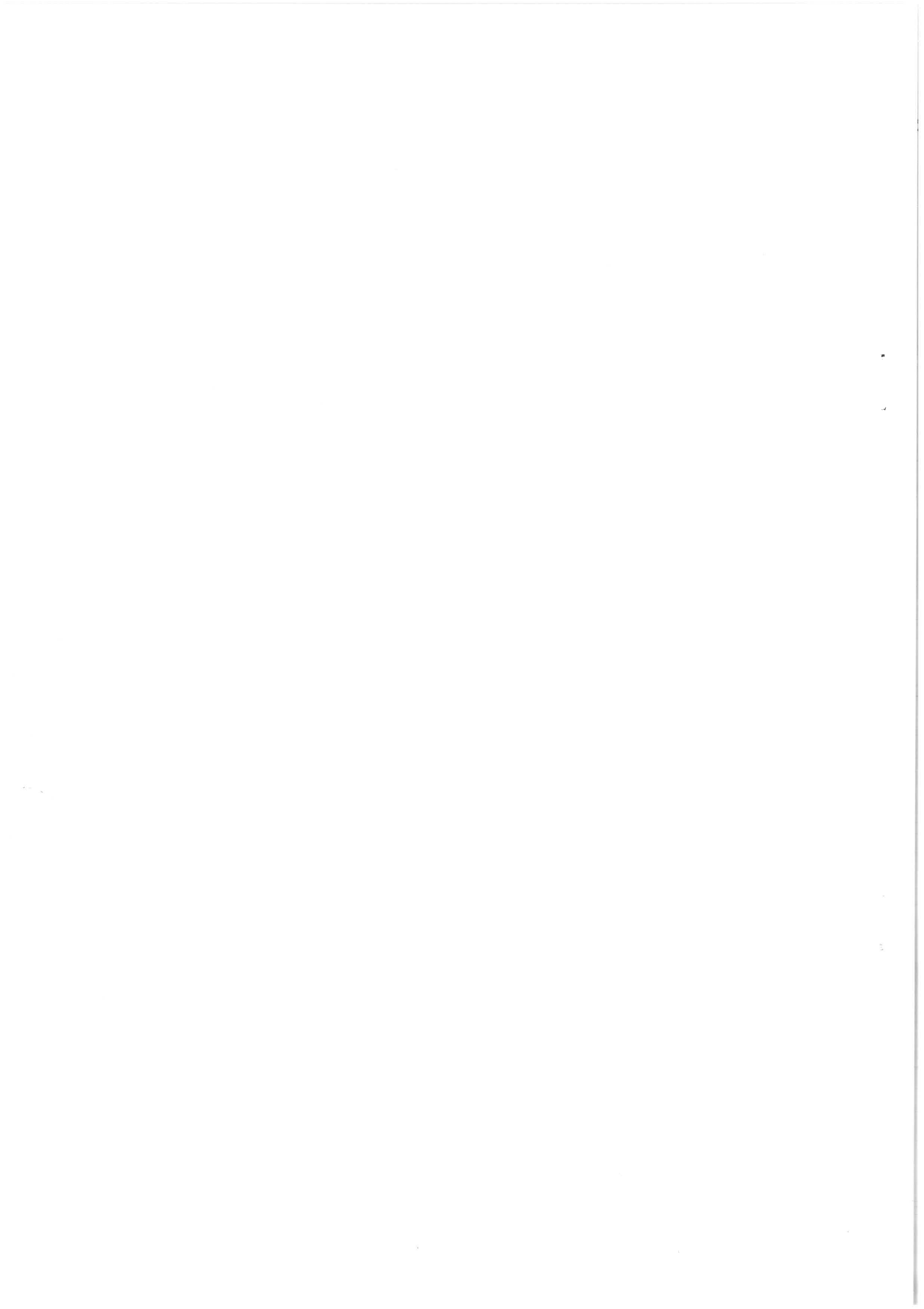

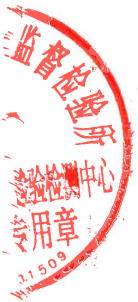


# 注 意 事 项
